

AFFIDAVIT CUM CONSENT OF OWNER

(Note : To be executed in Rs.20/- Non-judicial Stamp Paper) _____ S/o, D/o, w/o, c/o
_____ R/o _____ (“Deponent”) do hereby solemnly affirm & declare as under:-

1. That, I undertake that i am the absolute owner/Co-owner of the house / shop / commercial property bearing no. _____ situated at _____ (“Scheduled Property”).
2. That, the applicant Shri _____ S/o _____ R/o _____ is well known to me as he is my relative/neighbour/friend/co-worker/tenant and now the said applicant requires a temporary electricity connection at my above said property for the purpose of _____, and whereas, being the owner of the said scheduled property, I give my permission & consent for temporary electricity connection to the above applicant and also declare that I have no objection if the Discom (“TPNODL”) releases a new temporary electricity connection at the above scheduled property in the name of the applicant Shri _____ for a period of _____ days or till the successful completion of the above objective of the applicant.
3. I hereby declare and undertake that the tenant shall pay the electricity bills to the DISCOM in time and shall use the electricity only for the specified purpose, for which the electricity connection has been released.
4. I undertake that the electricity connection will not be used for any illegal activities and if it happens, I will immediately inform the electricity DISCOM (TPNODL) about the same. In case of my failure, the DISCOM (TPNODL) will free to take appropriate legal action against me including recovery of damages /losses and pending arrears.
5. I undertake to comply with the prevalent electricity rules and regulations issued by appropriate authority including OERC/CEA/ appropriate Govt.
6. I undertake that, under no circumstances will the DISCOM (TPNODL) and its Management, Officer, Engineers, representative etc be liable for any kind of losses/damages/ compensation etc. in case of any dispute arises between me and the above said applicant for the said electricity connection **or** between the actual land owner/co-owner for the scheduled property.
7. I undertake that, under no circumstances will the DISCOM (TPNODL) and its management, officers, engineers, representatives etc. be liable for any loss /damage /compensation, If the local administration takes any legal action against me and any third party including above applicant for any illegal activities being carried out on the scheduled property.
8. I further undertake that, if i suffer any loss due to the said temporary electricity connection issued in the name of the above applicant, I will not sue the DISCOM and its management, officer, Engineer, representative etc under any circumstances.
9. I also undertake to indemnify the DISCOM for any loss/damage caused by the negligence of me including any third party as well as the above applicant.
